

## TERMS AND CONDITIONS OF WARRANTY

- 1. Zakłady Kablowe BITNER Sp. z o.o. hereby warrants that cables and conductors supplied by us are high-quality products manufactured in compliance with applicable standards and can be used in electrical circuits subject to the relevant principles of their intended use, transport, storage, laying and operation as set forth in the applicable standards and regulations.
- 2. Zakłady Kablowe BITNER Sp. z o.o. undertakes to cover the costs of rectification of any physical defects caused by the manufacturer in the cables and conductors supplied, provided that the Customer reports the physical defect in writing within three days of identification thereof.
- 3. The Warranty covers the cables and conductors supplied by Zakłady Kablowe BITNER Sp. z o.o. based on a VAT invoice.

## THE WARRANTY PERIOD FOR THE CABLES AND CONDUCTORS IS 24 MONTHS OF THE PURCHASE DATE

- 4. The Warranty shall cover any physical defects in the product that occurred solely for the manufacturer's fault.
- 5. The Purchaser may exercise the rights under the Warranty, if the Purchaser:
  - has the proof of purchase of the cable or conductor in the form of a VAT invoice,
  - ensured proper transport, storage, laying and installation of the cable and/or conductor by duly qualified persons, and carried out the as-built and periodic performance tests of the cable line,
  - properly secures the place the defect has been identified and enables the supplier's representative to inspect the same, as well as makes available the records of the results of the acceptance and performance tests of the cable line.
- 6. Zakłady Kablowe BITNER Sp. z o.o. undertakes to examine the complaint within 14 days of the date the physical defect of the cable or conductor was duly reported and to subsequently determine the manner of further proceeding within the time period agreed with the Purchaser.
- 7. Where the entire cable or conductor section, or any part thereof, with the physical defect identified is replaced, the defective section shall be the property of Zakłady Kablowe BITNER Sp. z o.o. and must be returned to it upon request of the company's representative.
- 8. Liability under statutory warranty shall be excluded.
